

2026 SUPERHERO CHALLENGE TERMS AND CONDITIONS OF PARTICIPATION AND LIABILITY WAIVER

Participation in the 2026 Norfolk Superhero Challenge on Saturday 20th June 2026 (the "Event") is subject to and conditional upon the following terms and conditions:

As used in this Agreement:

- (a) "Event Organisers" means and includes Norfolk Superhero Challenge Limited, its directors, partners, licensors, and any and all subsidiaries, affiliated entities, or entities that control, are controlled by, or are under common control with the Event Organisers singly or together and its and each of their officers, employees, volunteers assisting in the staging of the Event, contractors, subcontractors and agents and each of their agents, representatives, successors and assigns;
- (b) "Participant", "You" or "Your" means and includes You (as an individual and Participant and any Third Party) applying to enter the Event, and any Supporters and, by virtue of agreeing to this Agreement, for whom You are waiving certain rights.
- (c) "Supporters" means any non-participating, accompanying person/s who are attending the Event in support of You, including any family members or friends and including any minors.

ACCEPTANCE OF CONDITIONS

Please read these terms and conditions of participation and liability waiver ("Agreement") carefully, as it affects Your future legal rights.

Participants must be at least 18 years of age on Saturday 20th June 2026 to take part in the Event.

Participants who are aged under 18 years of age during the registration process must be registered by a parent, legal guardian or carer on their behalf. Parents, legal guardians or carers registering on behalf of a Participant shall be deemed to have accepted these terms and conditions on the Participant's behalf and further agree to take full responsibility for such Participant during the Event.

Only people properly registered in accordance with this Agreement are eligible to take part in the Event.

The Participant shall be deemed to have accepted these terms and conditions and to have entered into a legally binding contract with the Organiser when they accept the terms and conditions of participation by clicking the relevant field in the online registration form ("Online Entry Form").

Should Participants breach these terms and conditions, the Event Organiser reserves the right to (i) disqualify such Participants from the Event, and/or (ii) exclude such Participants from participation in future events organised by the Event Organiser. In such circumstances, no refunds of any kind shall be payable.

Participants acknowledge that the Event is physically strenuous and that they are aware of the associated medical and physical risks involved. By completing the Online Entry Form Participants warrant to the Event Organiser that they are sufficiently fit and healthy to participate in the Event unaided (and acknowledge that they must reaffirm that they are sufficiently fit and healthy to participate in the Event unaided on the date of the Event) and agree to be solely responsible for their actions, and the Event Organiser, its officers, agents, employees, affiliates, sponsors or medical advisers shall not be responsible for any injury or illness that a Participant may suffer as a result of their participation in the Event (unless caused by the negligence of the Organiser or its officers, agents, employees, affiliates, sponsors or medical advisers).

The Event Organisers is released from liability. By agreeing to enter the Event, You hereby waive, release and forever discharge, for Yourself, Your heirs, executors, administrators and legal representatives, any and all rights and/or claims which You may have against the Event Organisers (including any of its officers, directors, employees, consultants, agents and Event sponsors) for any and all damages and/or claims which may be sustained by You directly or indirectly arising out of Your participation in the Event (including the application of emergency or medical services at the Event).

You agree not to take any action against the Event Organisers, its officers, directors, employees, consultants, agents and Event sponsors for any and all damages and/or claims which may be sustained by You directly or indirectly arising out of Your participation in the Event. This release and discharge includes, but is not limited to, claims for property damage, any indirect or economic loss, breach of contract, lost wages, contribution indemnity, other indemnities, punitive damages, or any other legally recognisable claim arising out of Your participation in the Event (including all legal costs associated with such claims).

Your indemnity re Third Party Claims. You hereby agree to indemnify the Event Organisers (including any of its directors, officers, employees, agents and consultants) against any and all claims, lawsuits and causes of action whatsoever or howsoever arising and brought against them by any third party as a result of Your actions and/or participation in the Event, including without limitation, the violation of any laws or regulations by You or Your breach of these terms and conditions.

AUTHORITY TO REGISTER AND/OR TO ACT AS AGENT

You represent and warrant to the Event Organisers that You have full legal authority and capacity to complete the Online Entry Form, including accepting these terms and conditions, on behalf of Yourself and any party for whom You are registering (the "Third Party"), including full authority to make use of the credit or debit card to which fees related to event registration will be charged.

By registering Your teammate (Third Party), You are confirming that the Third Party contact details provided are accurate, correct and up to date. The Third Party will be sent a confirmation email. By participating in the Event, the Third Party will be deemed to have

accepted these terms and conditions.

By completing the Online Entry Form and participating in the Event, Participants agree that this Agreement shall apply equally to Supporters.

EVENT INFORMATION

All necessary information pertaining to the Event is published on the Superhero Participant Portal on www.norfolksuperhero.co.uk . Event information is not posted to You in hard copy format. However, the Event Organisers will provide regular newsletters about the Event and inform You when new Event information is available via email. It is Your responsibility to provide the Event Organisers with a valid email address. The Event Organisers cannot be held responsible for any failure to deliver important information or updates where such failure results from (i) incorrect or incomplete contact details provided by the Participant; (ii) the Participant unsubscribing from the Event Organiser's mailing list; or (iii) the same email address being used for multiple Participants. Please note that details of the Event, as published for example on the Online Entry Form, Your personal ResultsBase account or the Event information pack, are subject to change. Details of any alterations to Event information will be made available on the Superhero Participant Portal. It is Your responsibility to ensure You have accessed the relevant information relating to the Event.

EVENT ENTRY FEE

The Event Entry Fee is £275 per person. All Event Entry Fees are paid via the ResultsBase online registration platform ("Registration Platform") and are inclusive of VAT at the prevailing rate (variable). If an entry is accepted, the Event Entry Fee is non-refundable other than as stated in the relevant clause under CANCELLATION, ALTERATION AND TIMINGS OF EVENT BY THE EVENT ORGANISER of these terms and conditions.

Booking fees for use of the Registration Platform used to complete the Online Entry Form will be chargeable in addition to the Event Entry Fee and such booking fees will not, under any circumstances, be refunded.

If payment cannot be collected for any reason, including, without limitation, due to expired card, lack of funds, incorrect card details or revocation by You (including at a later date), the relevant Participant for which the entry was purchased cannot participate in the Event and You may be charged a withdrawal fee.

The Organiser will not be liable under any circumstances for any costs incurred by the Participants in relation to the Event, including without limitation any accommodation and/or travel costs.

EVENT REGISTRATION

Participants must complete the appropriate registration process via the Registration Platform by the deadline set by the Event Organiser. Any Participant who does not complete the registration process by the deadline set by the Organiser, will lose their right to participate in the Event and their Event entry will be voided, with no right to receive a

refund in relation to any amounts already paid or associated booking fees.

Your entry is confirmed only once the Event Organisers confirm receipt of Your Event Entry Fee and a fully completed Online Entry Form, which includes Your acceptance and agreement to the terms of this Agreement.

The Event organisers may ask for photo identification during the Friday check-in (e.g. passport or driving licence). Photocopies or photographs are acceptable. No registration (or taking part) will be permitted without providing photo identification in accordance with this clause. If a Participant cannot appear personally to register, they must inform the Event Organiser in writing in advance (hq@norfolksuperhero.co.uk).

Entries to the Event are personal to You. You are strictly prohibited from swapping, trading, giving away, selling, donating or transferring or offering to do so. A sell, swap, give away, trade, donate or transfer of Your place in the Event or attempt to do so is grounds for cancellation of entry by the Event Organiser without refund or other compensation of any kind.

UPDATING PERSONAL DETAILS AND CHANGING PARTNERS

Participants are responsible for ensuring all their contact details, medical information and other event information (eg race category) are correct and up to date before Friday 19th June 2026. Participants will need to login to their Resultsbase account to check all the information is correct and make any amendments themselves. Furthermore, it is your responsibility to notify the Organisers of any and all changes to medical conditions, allergies and medication following your original registration in November 2025. Notification will only be deemed as having been made if confirmation of this change is confirmed back to You by the Organisers. It is also Your responsibility to ensure that changes to medical conditions, allergies and medication are again highlighted to check-in staff on the day of check-in.

If a Participant needs to change their teammate (due to injury, illness, etc), this can only be done during the 'change window' between 1st May and 8th May 2026. Participants will need to login to their Resultsbase account and make the changes themselves.

It is important to note that one member of the team who originally entered in November 2025 must be part of the re-confirmed team on the 8th May deadline. Full team changes are not allowed.

It is at the sole discretion of the Event Organiser as to whether any Participant and team changes are accepted. Your team place is only confirmed once The Event Organisers confirm your changes.

The Event organizer will contact all teams in late April 2026 to let them know that the entry system will reopen between 1st May and 8th May. Please do not contact the Event Organiser for team changes before this time.

ELEGANT PASS

If You wish to take an Elegant Pass You must notify the Event organisers by the deadline

specified on the Online Entry Form. Elegant Passes are not available after this date. You will need to specify which year You wish to take the Elegant Pass for. If You don't take up Your Elegant Pass on your specified year, You may not be invited back the following year and will have to rejoin the back of the waiting list if You would like to take part again. Once deferred, the entry is non-refundable and non-transferrable.

WITHDRAWALS

The Participant acknowledges that places for the Event are limited and registrations for places have a direct impact on the organisation and logistics of the Event, as well as the total charity raise.

A Participant may request to withdraw from the Event at any time by contacting hq@norfolksuperhero.co.uk. Please note as per the clause above, Elegant Passes are not available after the deadline specified on the Online Entry Form.

The Event Entry Fee is non-refundable. However, if You withdraw with a valid reason before 1stMarch 2026, at the sole discretion of the Event Organisers, part of Your Event Entry Fee may be refunded. Booking fees will not be refunded under any circumstances.

CHARITY PLEDGE

You and Your team partner will each pledge to raise £375 (£750 as a team) for the chosen charity of the Norfolk Superhero Challenge 2026. Golden ticket holders have pledged to raise £3,100 as a team.

Your team Justgiving fundraising place must be set up by 27th April 2026 when You must email hq@norfolksuperhero.co.uk with your page's url.

Your team total of £750 (or £3,100 as a Golden ticket holder) should ideally be in place by the time of Your check-in on Friday 19th June 2026, at which point You may be requested to show proof of Your fundraising.

Should fundraising not be in place before the Event You will have up to the 4th July 2026 to complete Your fundraising and You will be required to share proof of Your fundraising with the Event Organisers.

If for any reason You or Your team partner choose not to take up Your place or the Event is cancelled or postponed, or You are not permitted to take part in the Event, all sponsorship forms and money collected for the Norfolk Superhero Challenge's chosen charity must be forwarded to the charity and will not be refunded.

Any team not meeting their combined minimum charity pledge of £750 (or £3,100 as a Golden ticket holder) may not be invited back the following year and will have to rejoin the back of the waiting list if they would like to take part again.

Thank you very much for all your efforts in supporting local causes.



CHARITY PLEDGE AND REPLACEMENTS

Due to the large number of replacements during last year's event, the Event Organisers would like to ensure that the minimum charity obligation across the event is still met, either individually or as a team, even in the event of replacements being drafted in.

- 1. If for any reason an individual member of a team is replaced, it is expected that between the person who is replaced, the team partner who is still taking part in the Event and the replacement who has been drafted in, that between them they will still meet the team's minimum charity pledge obligation of £750, or £3,100 as a Golden ticket holder.
- 2. If for any reason Your team withdraws from the Event, the following sliding scale of charity commitment obligations will still apply for Your team, expressed as a percentage of the total minimum charity pledge of £750, or £3,100 as a Golden ticket holder. The chosen charity would be grateful for anything raised above these minimum commitments.

a. Withdrawal 30 days or more before the event: 0%

b. 29 - 14 days: 25%c. 13 - 7 days: 50%d. 6 days or less: 75%

- 3. Any entire team coming in as a replacement prior to the event is subject to the following reduced charity minimum pledge obligations depending on the timing of their replacement, expressed as a percentage of the total minimum charity pledge of £750, or £3,100 as a Golden ticket holder. The chosen charity would be grateful for anything raised above these minimum commitments.
 - a. Replacement coming in 30 days or more 100%

b. 29 - 14 days: 75%c. 13 - 7 days: 50%d. 6 days or less: 25%

The balancing effect of 2) and 3) above is designed to ensure that there is clarity on the minimum charity pledge being met in the event of a replacement. Any variation to the above will be allowed should the team who is replaced and the replacement team agree to meet the minimum charity pledge in whatever proportion between them.

The Participant acknowledges and accepts that circumstances concerning the Event may change from time to time for reasons outside of the Event Organiser's reasonable control or otherwise, without the Organiser incurring any liability and without any rights to withdrawal being accrued by the Participants save as expressly set out in these terms and conditions.

The Norfolk Superhero Challenge may at any time be cancelled, re-routed or stopped for reasons of safety or if Government regulations require the Event Organisers to do so. The Event Participation Fee and any costs incurred by Participants will not be refundable. There shall be no further liability whatsoever arising from such change of format, course, distance or cancellation.

The Event Organisers reserve the right to amend the Event format, including changing the course and the distance, at its sole discretion. If the Event format, course or distance, is changed, the Event Participation Fee and any costs incurred by Participants will not be refundable. There shall be no further liability whatsoever arising from such change of format, course or distance.

Any last-minute amendments to the Event, including a last-minute cancellation, will be made entirely at the discretion of the Event Organisers. If the Event is prevented from taking place at the last minute or must out of necessity be changed - e.g. the route altered - then the Event Participation Fee and any costs incurred by Participants will not be refundable. There shall be no further liability whatsoever arising from such change of format, course, distance or cancellation.

The Event is subject to cut-off times. For the safety of both Participants and volunteers, the Event Organiser has the right to remove, from the Event, those Participants who do not meet the applicable required cut-off times. No refunds will be paid to Participants in these cases. The relevant cut-off times will be notified in the Event information pack and at the safety briefing on Friday 19th June 2026 , and are subject to change at the Event Organisers' discretion.

The Event Organisers reserve the right to change the date of the Event. In the Event of such change of date of the Event, and You and Your team partner are unable to attend on the revised date, You have 7 days to inform the Event Organisers in writing from when the change in date is announced to receive a refund of Your Event Entry Fee. If You have not replied within the 7 days, Your Event Entry Fee will be donated to charity: the Norfolk Superhero Fund helping to get children active.

INSURANCE

The Event Organisers will not carry insurance in relation to Your participation in the Event. You accept that the Event Organisers have made it clear to You in advance of the Event that no personal insurance will be provided. It is Your responsibility to obtain accident/medical insurance and third-party liability insurance in connection with the Event. We also recommend You obtain cancellation insurance.

You must be fully insured to participate in the Event and must make sure that all of the activities in the Event are covered by such insurance. You should always check Your policy for any exclusion of activities undertaken in the Event.

MEDICAL

Participants acknowledge and agree that:

- The Event for which You are registering may be physically challenging and may pose a risk of discomfort, illness, injury, and even death. You need to be satisfied that You are physically capable of doing the Event without undue risk to Your health or Your life. You are strongly advised to consult a doctor before undertaking any strenuous exercise or training programme or participating in the Event. The Event Organisers do not conduct health or fitness checks on participants. The Event may involve inherent risks and dangers to participants and observers and, accordingly, You participate or observe at Your own risk. You warrant that You will be sufficiently fit and healthy to participate in the Event unaided and in accordance with this Agreement.
- The Event Organiser reserves the right to remove any Participant from the Event, either during or before it, due to ill health, or any other reason (at the Organiser's discretion) that may render them unfit to safely complete the Event. Each Participant confirms that they will not take part in the Event if they are suffering from any injury or illness which may impair their performance and confirms that they will report any illness during the Event to the Event medical team immediately.
- Participants' personal information (including medical information entered on the Entry Form or collected by Event medical staff during or after the Event) can be stored, used and disclosed by the Event Organisers in connection with the organisation and administration of the Event and for the compilation of statistical information. If You become ill during or after the Event and/or receive medical attention or treatment either from Event medical staff, Ambulance staff or any doctor or hospital, You authorise such persons to provide details (including details of medical treatment) to the Event Organisers or others authorised by them.
- It is Your responsibility to let us know if any of the information You have shared with us prior to the Event in relation to medical or allergies has changed. For expert opinion on these matters and Your participation in the Norfolk Superhero, please consult Your GP or doctor.
- It is Your responsibility to write Your next of kin and contact details on the back of Your race number using a waterproof pen. Also, if You have any type of medical condition or are taking any type of medication please write a large 'MC' on the bottom left of Your race number, please write Your medical condition fully on the back of Your number. This will only be used in the event of You being involved in an accident.
- You consent to medical assistance and/or medical care being given to You in the case
 of illness, injury or an emergency situation, should this occur during the Event, such
 assistance to be given by the Event Organisers, its employees, contractors or other
 trained personnel conducting the Event (which may include the use of anaesthetics).
- You understand that no medical care may be available, but if it is, You assume liability
 for any and all medical expenses incurred as a result of Your participation in the Event
 (where such medical expenses are not provided on a free of charge basis by any
 medical services organizations, clinics, or hospitals), including, but not limited to
 ambulance transport, hospital stays, physician, and pharmaceutical goods and
 services.
- The Event Organisers may from time-to-time issue reasonable rules or conditions to address Covid-19 including, but not limited to, testing, social distancing and/or the use

- of monitoring or tracking devices or software. You warrant that You will comply with all such rules or conditions.
- You and Your team partner agree not to attend the Event should You suspect that You have been in contact with anyone with Covid 19 or any of its variants or if You have any symptoms at all in the 10 days prior to the Event (such period being subject to any Government Guidelines at the time of the Event).

PARTICIPANT OBLIGATIONS

Please be mindful at all times that You are a Norfolk Superhero and You are representing the Event in the community, and that we want to set a positive example of the Norfolk Superhero as a fair, fun and sporting Event that inspires those that take part and watch the Event.

As a continuing condition of entry into, and participation in, the Event, Participants shall ensure that:

- Participants must attend the compulsory safety briefing at the Event HQ at 6:30 pm on Friday 19th June 2026.
- Participants are responsible for ensuring that their kit meets the safety standards required and are expected to follow the advice given and to take personal responsibility. Participants not complying with the compulsory kit (see KIT LIST AND COMPULSORY ITEMS below) may be disqualified from the Event.
- Participants are responsible for ensuring all their contact details, medical information and other event information (eg race category) are correct and up to date before Friday 19th June 2026. Participants will need to login to their Resultsbase account to check all the information is correct and make any amendments themselves
- Prior to, during and after the Event whilst on the Event site, You and Your team
 partner are responsible for Your own safety. You will take all reasonable care to
 ensure the safety of other participants, Supporters, spectators, support staff and the
 general public. The Event Organisers will not be liable for any actions of any spectators
 or other third parties.
- Participants agree to abide by all Event rules, regulations and instructions issued by or on behalf of the Event Organisers, any rules and regulations imposed by the venue and all applicable rules and regulations of the relevant sporting governing bodies that oversee the running of the Event including the relevant BQA Rules in force (available on request by emailing HQ@norfolksuperhero.co.uk) and any road regulations, including without limitation, the Highway Code. The Event Organisers are entitled to impose Event rules upon You from time to time which will form part of these terms and conditions and all decisions and rulings by or on behalf of the Event Organisers shall be considered final.
- The Participants will comply with all instructions and guidelines given by the Event Organiser and all Event staff, stewards, marshals, and medical/safety personnel.
- Participants shall not intentionally or carelessly litter (including water bottles) onto the course at any point. Litter can be discarded in the transition area in the bins provided

at the Event HQ. Participants caught throwing litter are at risk of being disqualified.

- Participants must display the official Event numbers provided at registration in the manner indicated in the Event information pack; folding or defacing Event numbers will result in penalties being applied. It is Your responsibility to ensure the marshals get Your number at each checkpoint.
- If You retire from the Event, You must inform HQ as soon as possible. For safety reasons, Your team partner will not be allowed to continue and will have to retire at the same time.
- Participants must return any electronic timing wrist or ankle band or equivalent equipment to a marshal. Participants who do not return such equipment will be charged for its replacement.
- Teams will only be deemed as having completed the course or section when the last member of that team has crossed the finish line, this time becomes the official finishing time for that team's entry.
- The Norfolk Superhero Challenge is subject to cut-off times, which will be advised at
 the compulsory safety briefing. The cut-off times are non-negotiable. Participants who
 miss the cut-off times will be asked to stop at that point of the event. The cut-off times
 may be subject to change for the safety of both participants and volunteers.
- Any external help, including waving through at junctions and pacing/drafting behind a
 car during the bike leg and drafting behind a non-participating boat during the kayak
 leg, will result in disqualification. This is cheating.
- For safety reasons, You may not use Your mobile phone, electronic listening communication device or personal video recording device at any time whilst participating in the Event. Mobile phones should only be used in case of emergency.
- Food and beverage products given out at the Event may contain or may have been
 prepared alongside common allergens, including but not limited to nuts, dairy, gluten,
 and soy. It is Your sole responsibility to check ingredient information and ensure the
 suitability of any products You elect to consume. The Event Organiser shall not be held
 liable for any allergic reactions, illnesses or injuries.
- Participants are responsible for not getting lost and not deviating from the official Event route. You can find the Event route map on the Superhero Participant Portal on www.norfolksuperhero.co.uk, in Your Event information pack and at the safety briefing, and the bike route on mapometer
 - **gb.mapometer.com/cycling/route_3794802** which You can upload to an electronic device. Contact numbers for HQ and the roving bike mechanics can also be found on the map provided. The route will be marked by Norfolk Superhero Challenge signs but please be aware that we cannot be responsible if signs have been moved.

The Event Organisers reserve the right to remove You from the Event, either during or before it, due to ill health, for not following the event rules, for not using the correct equipment or

any other reason (at the Event Organiser's discretion) that may render You unfit to safely complete the Event. In such circumstances, no refunds of any kind shall be payable.

The Event Organisers also reserve the right to terminate Your participation should You be considered not to be treating other participants and other participant's property, the Event Organisers or its personnel (including that of its suppliers and subcontractors) with respect at all times or if You are otherwise considered to be a danger to the safe staging of the Event. In such circumstances, no refunds of any kind shall be payable.

BIKE LEG

The 45-mile bike route is all on open roads. You must obey all road traffic legislation and Highway Code Rules; failure to do so may lead to disqualification. Most of the route will be on minor roads but these will not be traffic free. Particular care should be taken on those sections of the route on single track roads and where there may be pot-holes, gravel and loose stones. Look out for some sections of the route where we have marked the road to encourage You to slow down.

Event marshals will be located at various points along the route. Please note that marshals do not have the authority to stop motorists. Marshals are there to help in the safety of the running of the Event both for You and other road users. Please listen and obey their instructions. There will also be other emergency support around the course and a roaming bike mechanic. If You are in trouble then please flag them down or stop at an event marshal, both should have communication with Event HQ.

If for reasons of safety, marshals ask You to stop or slow down, then please do so. You will be required to make Your own judgement on whether it is safe to proceed at every junction. We recommend You unclip Your cycling shoes in good time, put a foot down, look and listen for traffic, and make Your own judgement as to whether it is safe to proceed at all junctions. You must display caution at all junctions, and particular caution at these junctions:

- Point 5 B1153 Crossing North
- Point 9 Sedgeford
- Point 13 Sandringham
- Point 15 Amner
- Point 20 Syderstone
- Point 23 South Creake
- Point 25 Holkham South Gate
- Point 28 Plum Crossing
- Point 1/30 Start/end of bike leg at BOS

The junctions above will have traffic management teams in place. In some instances, this may allow You to pass through with priority over the other vehicles on the highway. However, the Event Organiser cannot guarantee that vehicles will always stay within the law, so please proceed with caution at every junction. Please also note that traffic management teams do not have the authority to stop traffic. Please note and remember that traffic management isn't at all junctions — only those marked above. If, for reasons of safety, we ask You to stop or slow down, then please do so. It is Your responsibility to decide whether it is safe to proceed. Traffic Management teams are there to help. They are not Your eyes and ears.

Drafting and overtaking during the cycle.

Under no circumstances should You or Your team partner ride in bunches or cross the centre line of the road. You and Your team partner must ride in single file and keep to the left-hand side of the course and not create a hazard by blocking other participants on the course. You must only pass another participant on the right.

For Your own safety, it is forbidden to draft other teams. You must reject attempts by other teams to draft. Drafting endangers, You, Your fellow participants, event marshals and the general public.

If You are overtaking You should at all times ride in single file and observe a 12m gap between Yourself and the team in front. Any infringement will be met with time penalties and/or disqualification for multiple offences.

During the bike You must not take food or drink from a moving vehicle. If You need food or drink, You must bring Your bike to a complete stop in a safe place in order to receive it. You may receive support from a stationary vehicle and any such vehicle must not interfere with the progress of other participants or obstruct other traffic.

KIT LIST AND COMPULSORY ITEMS

A kit list is set out below. The Event Organisers reserve the right to change this list should it be considered appropriate for Participants' safety. There will not be compulsory kit inspections, although the Event Organisers reserve the right to do a spot-check of kit at any time during the Event if they are concerned for Your safety. You and Your team partner are responsible for ensuring that Your kit meets the safety standards required and are expected to follow the advice given and to take personal responsibility. Teams not complying with the compulsory kit may be disqualified from the Event.

Weather Conditions: The Event is an outdoor event which will take place in varied weather conditions. You are expected to prepare Yourself for the conditions of the day accordingly. The characteristics of the course and terrain may change in varying weather conditions. You are expected to use Your own judgment at all times when assessing these conditions and Your interaction with the course.

<u>Compulsory:</u> You and Your team partner are **responsible for carrying Your own water** throughout the Event. A water point will be available in the Transition zone to fill up Your water bottles. To help reduce single use plastic and reduce the impact on the environment, there will NOT be any other water provided along the course, except for emergency water at Sandringham on the bike and at Lady Anne's Drive on the run. Please consider how You will carry water on the bike and on the run. You will not be allowed to leave transition unless You have two water bottles <u>each</u> on the bike and a suitable water container <u>each</u> for the run. This may include, for example, hydration vests, runners water bottles or flasks.

<u>Compulsory:</u> You must also carry at least one **sufficiently charged mobile phone** between You during the bike and the run. Please consider how You will carry a phone on the bike and on the run.

<u>Compulsory:</u> We ask that You and Your team partner **download the what3words app** as an easy way to find, share and save Your precise location in case of an emergency. You and Your team partner are also advised to save an In Case of Emergency ("ICE") contact in Your mobile phone and to ensure that Your phone is sufficiently charged.

<u>Compulsory:</u> You must **wear the race number during the bike and the run**. The race number should be visible at all times: on the back during the bike and on the front during the run.

Swim: full length swim wetsuit (compulsory); goggles; Norfolk Superhero Challenge 2026 coloured swim cap (supplied by the Event Organisers and compulsory).

Kayak: Buoyancy aid to be worn and securely fastened at all times (supplied by the Event Organisers and compulsory for You and Your team partner to wear); if You are using Your own buoyancy aid please ensure it complies with CE Standard EN 393 (International Standard "ISO 12402"); **Malibu 2 Ocean kayak** for Men and Ladies only teams, or **Too Tega Pulse 120** for mixed teams (either supplied or Your own); windproof top.

Bike: It is Your and Your team partner's responsibility to check the safety of Your bike and ensure You have a mechanically sound and roadworthy road bike; Approved cycling safety helmets of ANSI Z90.4, SNELL B90, EN 1078 or an equivalent national standard must be worn by participants (compulsory). A CE mark is not an approval mark and should not be treated as approval. Helmets must be securely fastened and fit properly at all times from the moment of taking the bike off its rack in the transition area until putting the bike back on its rack in the transition area (compulsory for You and Your team partner); only traditional drop handlebars are permitted. The handlebars must be plugged; Tri-bars are NOT permitted; sufficiently charged mobile phone (1 per team is compulsory); 2 bottles of water or sports drink per person (compulsory). We also advise that riders have rear lights on their bikes, and that they carry energy bars or similar snacks, tools, replacement inner tubes, clothing appropriate to the weather conditions, ID, a small amount of money, sunscreen and map.

Run: a sufficiently charged **mobile phone** per team (compulsory); **1 bottle of water** or sports drink per person (compulsory). You must carry Your own water or sports drinks on the run. Emergency water will be available at Lady Anne's Drive. We also advise that runners carry clothing appropriate to the weather conditions.

It is important to drink regularly and enough before, during and after exercise. However, please note that drinking too much water before, during or after exercise can lead to a condition known as Exercise-Associated Hyponatremia. The symptoms of EAH can be mild (dizziness, nausea) to more dangerous (headache, vomiting, confusion, seizure) and can be lifethreatening. Please consult Your doctor for expert medical guidance.

ASSUMPTION OF RISK AND LIABILITY

You commit to participate in the Event with full knowledge and understanding of the risks associated with participation in the Event. It is Your sole responsibility to inform Yourself of the risks involved and You are strongly advised to take every reasonable precaution to avoid such risks. If You are unsure of such risks, You must contact us prior to the Event to obtain advice.

To the extent permitted by law neither the Event Organisers nor its sponsors, suppliers or volunteers assisting in the staging of the Event will be liable for any loss, harm, damage, illness

or injury however so caused (directly or indirectly), arising out of or in connection with or suffered during or as a result of, Your participation in the Event, provided always that nothing shall exclude liability for death or personal injury caused directly by the negligence of the Event Organisers or its employees, subcontractors or agents.

You agree to indemnify, defend, and hold harmless the Event Organisers and all other persons associated with the event, from all liabilities arising out of or in any way connected with (a) Your participation in the event, including without limitation any liability caused by negligence (including any negligent rescue attempt), the action or inaction of the Event Organisers, (b) Your and Supporters' use of the services of the Event Organisers or the Event site, or (c) any violation by You of any of this Agreement.

In consideration of the acceptance of Your registration and participation in the Event, You assume full and complete risk and responsibility for any discomfort, illness, injury, or accident which may occur while You are preparing for the Event, during the event, while You are on the Event site or while You are traveling to or from the event.

You acknowledge and agree that the event may be held over public roads and facilities open to the public during the event and upon which hazards are to be expected.

You also acknowledge and agree that participation in the event may carry with it certain inherent risks and dangers that cannot be eliminated completely ranging from risk of minor discomfort to catastrophic injuries including permanent disability and death.

You are aware of and assume all risks associated with participating in the event, including without limitation risks of permanent injury or death due to falls, obstacles, collisions with pedestrians or vehicles and/or fixed or moving objects and the negligence of other road users, contact with other participants, acts or omissions of other participants, effect of weather, traffic and conditions of any road or terrain throughout the course.

DISCLAIMER OF WARRANTIES

You expressly agree that use of the Event Organisers' services is at Your sole risk. The services are provided on an "as is" and "as available" basis. The Event Organisers make no warranty that services will be uninterrupted, secure, or error free. The Event Organisers expressly disclaims all warranties of any kind, express or implied, including without limitation any warranty of merchantability, fitness for a particular purpose, or non-infringement. The Event Organisers do not guarantee the accuracy or completeness of any information on, or provided in connection with the Event. The Event Organisers are not responsible for any errors or omissions, or for the results obtained from the use of such information.

WAIVER, RELEASE OF LIABILITY COVENANT NOT TO SUE

In consideration of being allowed to participate in any way in the Event, You acknowledge, appreciate, and agree that: The risk of injury and/or death from the activities involved in the Event is significant including, but not limited to the following: (i) drowning; (ii) near-drowning; (iii) sprains; (iv) strains; (v) fractures; (vi) heat and cold injuries; (vii) over-use syndrome; (viii) injuries involving vehicles; (ix) animal bites and/or stings; (x) contact with poisonous plants; (xi)
